

Pastoral Motions

Congregational Meeting

January 12, 2025

Motion: To approve the call of Rev. Dr. Peter Dunn as the Co-Pastor/Senior Pastor, including the Terms of Call as presented.

Rationale: At the March 17, 2024, Congregational Meeting, the CPNC was charged to present a co-pastor candidate to the congregation to provide a transition toward Pastor Mike's retirement. The congregation will call the next senior pastor when calling a new co-pastor. "When a congregation has two pastors serving as co-pastors, and the relationship of one of them is dissolved, the other remains as pastor." *Book of Order G-2.0504*

Motion: To concur with the dissolution of the pastoral relationship between Solana Beach Presbyterian Church and Rev. Dr. Michael J. McClenahan, effective April 1, 2025.

Rationale: Pastor Mike is initiating the dissolution of the pastoral relationship in order to retire from 35 years of full-time ordained ministry and 22 years of service at SBPC. The request will be sent to the Presbytery of San Diego for approval at the February 22, 2025 meeting. "An installed pastoral relationship may be dissolved only by the presbytery. Whether the minister of Word and Sacrament, the congregation, or the presbytery initiates proceedings for the dissolution of the relationship, there shall always be a meeting of the congregation to consider the matter and to consent, or decline to consent, to dissolution" *Book of Order G-2.0902*
